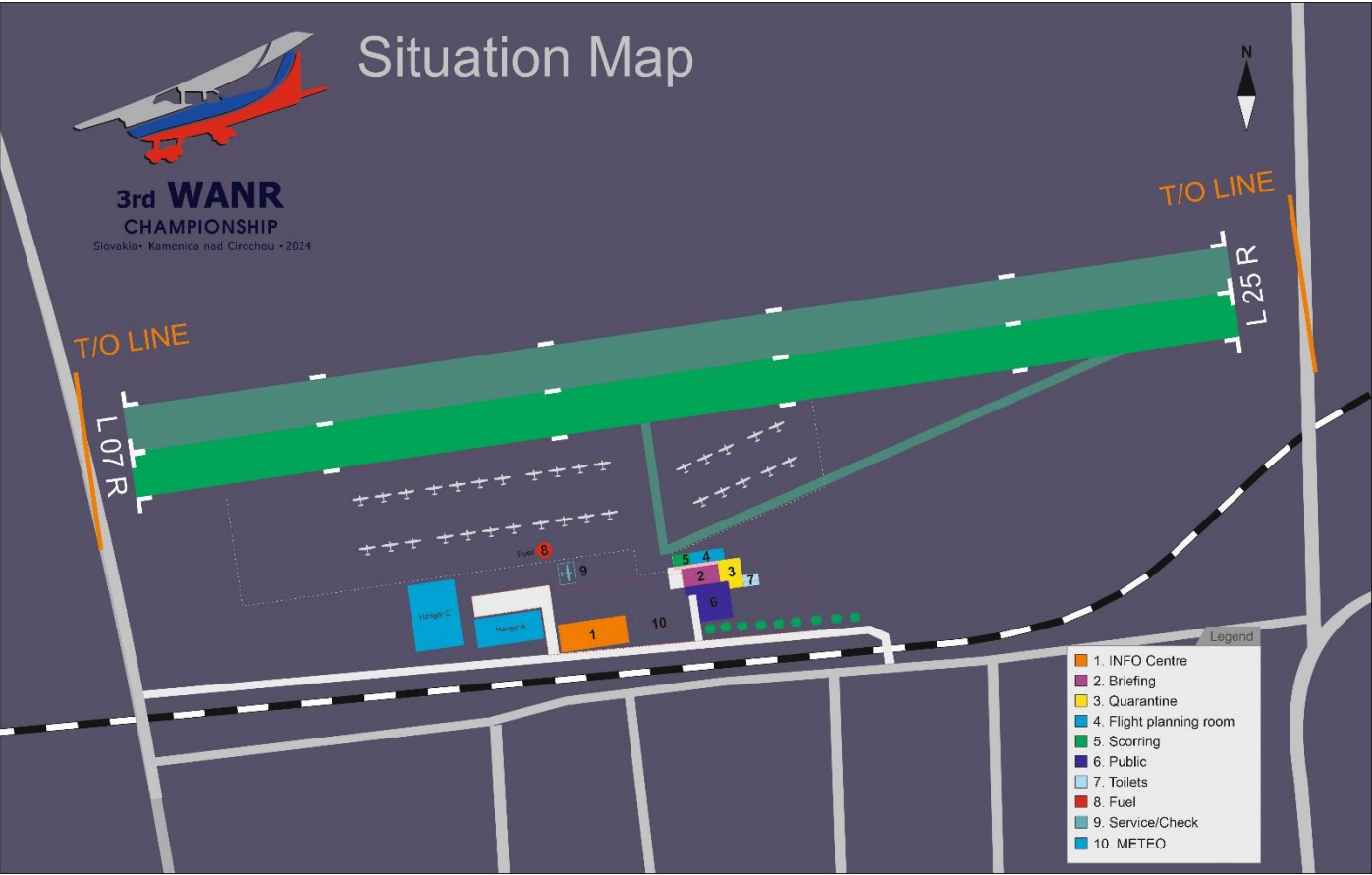

C.5.2 Official Entries

Entry Fees should arrive no later than *May 31st 2024* at the e-mail: aeroklubkamenica@gmail.com or address stated in C.15 and the bank account stated in C.6.1 in Local Rules.

C.5.3 Late Entries

Late Entries received *after May 31st 2024* may be accepted if there are vacancies, at the discretion of the organizer and in combination with payment of the fee for late entry stated in C.6.

If a NAC sends a final entry but fails to pay the required entry fee, that NAC shall lose its right to participate in this competition.

C.5.4 List of Official Entries

A final confirmation of all received Official Entries will be sent on *June 15th 2024* to all nominating NAC's and a complete list will be published on the competition website www.wanr2024.sk.

C.5.5 Non acceptance of Entries

Entries received after *30th of June 2024* will not be accepted. Up to the official start of the championship only changes of entries according to C.5.2 and C.5.3 may be accepted by the organizer.

C.7.4 Validation of Licenses

The pilots must be able to document in the form of declaration of the respective countries authorities that their certificate is in accordance with ICAO

Annex I. If the evidence is not sufficient, pilot training may be needed to fulfill the requirements as imposed to be flying in Slovakia registered aircraft.

Furthermore, pilots must provide a RT license with valid ICAO language proficiency in English language according to ICAO/ FCL.055 – minimum level 4 and valid medical certificate.

Slovak Transport Authority will authorize representative in Aeroklub Kamenica nad Cirochou (Organizer) to ensure the validation of licenses with Transport Authority.

Procedure requested by Transport Authority to follow and provide following documents:

1. *The applicant submits the application with the required attachments to the Transport Authority.*
2. *Required attachments:*
 - a. *ID card (issued by SR) or passport (foreigners) - copy.*
 - b. *A valid pilot license (copy) issued in accordance with the Chicago Convention.*
 - c. *A valid medical certificate (issued in accordance with the Chicago Convention).*
 - d. *Confirmation of the applicant's participation issued by the organizer of the competition or air show, which must contain the following information:*
 - i. *how will be ensured that the pilot is familiar with the relevant safety information, and how the risks associated with these flights will be managed,*
 - ii. *details of the competition or air show: name and venue of the competition or air show.*
3. *Payment of administrative fee in the amount of EUR 50 (item 91d letter b) point 5 of Act no. 145/1995 on administrative fees; by stamp duty or by transfer on the basis of a payment order issued by the Transport Authority)*

C.9. ARRIVALS

C.9.1 When arriving by airline, the nearest airport is:

- Košice International Airport (LZKZ) 70 km away from the competition site and can be reached within 1 hour by car.
- Porad-Tatry International Airport (LZTT) 160 km away from the competition site and can be reached within 2 hour by car.
- Other international Airport in distance of more than 300 km are Bratislava International Airport (Slovakia) Budapest International Airport (Hungary) or Krakow International Airport (Poland) or Vienna International Airport (Austria)

Arrivals with own aircraft can be planned directly to the Airfield Kamenica nad Cirochou (LZKC). Please inform Organizer by e-mail at least one day in advance. If you will need assistance please contact organizer on e-mail: aeroklubkamenica@gmail.com
